BOARD OF EDUCATION MONTVALE, NEW JERSEY

WORKSESSION MEETING MINUTES JANUARY 8, 2018

The Board of Education of the Borough of Montvale, County of Bergen, State of New Jersey, entered Worksession Public Meeting Session on Monday, January 8, 2018 in the Instructional Media Center of Fieldstone Middle School, Spring Valley Road, Montvale NJ. President Rossig called the meeting to order at 7:43 p.m. Roll call showed the following to be present: Mrs. Bagdat, Mrs. Baskin, Mr. Carvelli, Mr. DiFiore, Mrs. Foley, Mrs. McGauley-Eichorn and Mr. Rossig. Also present were Dr. Petersen, Superintendent of Schools, Mrs. Wasserman, Board Secretary/Business Administrator and 3 members of the public. Mr. Rossig reminded those present that the open public meetings notice was previously read.

SUPERINTENDENT'S REPORT

Dr. Petersen welcomed everyone to the first meeting of 2018. He is looking forward to an exciting year and added that 2017 was a great year. The first snow day of the year took place on Thursday January 4. Two students recorded the snow day message which was well received. The MEF auctioned off the recording opportunity at the Fall Casino Night event.

The upcoming Board meeting on January 22 will include a presentation on summer plans and activities scheduled to take place at Memorial Elementary School. The Innovation Team will be doing a site visit on January 30 and all Board members were invited to attend. The Pascack Valley Regional Board of Education meeting will take place on Tuesday February 13, the discussion will focus on the regional math curriculum. On February 6, the regional schools are hosting a speaker, William Deresciewicz, who will discuss his book "Excellent Sheep" at 7pm. Fieldstone School has received a request to host students visiting from China for one day. The visiting students will shadow a Fieldstone student, it should be a great experience for all involved.

Enrollment - Memorial currently has 529 students, no change from December. Fieldstone's enrollment increased by 4 students to 473 bringing the district total enrollment to 1,002.

She also shared the she will remain as the town council's liaison to the Board of Education and the local TV station.
